he Centre for Public Policy (CPP) at Chandragupt Institute of Management Patna (CIMP) is established concomitant with the mission of CIMP 'to establish centres of research' to evolve as an avant-garde public policy think-tank; engaged in policy research, analysis, debate, capacity building and consulting; catalysing fast-tracked, inclusive, and sustainable societal development. The Centre aspires to be the largest public policy repository and provide a platform to strengthen policy-making through cutting-edge research on policy interventions for enhanced effectiveness, applicability and governance. CPP through its different initiatives endeavours to nurture a close-knit interactive relationship at different levels between the various stakeholders of the public policy--- the executive, legislature, bureaucracy, judiciary, academia, policy/advocacy agencies, interest groups, quasi-governmental organizations (QGOs), non-governmental organizations (NGOs), industry, and the private and the 'third' sectors.

Key Activities

- To provide consultancy services to various levels of governmental, non-governmental
 and intergovernmental organisations in areas of field research, competing service
 delivery mechanisms and policy administration and management.

- Understanding economic pressures on governments and how economists across the world analyse public policy
- Understanding the challenges of implementing effective policies across a range of political environments and issue areas
- Law and Public Policy discusses legal systems, legislation, and law both as a constraint on government and as applicable beyond the nation-state
- Policy Evaluation to demonstrates the contribution that research evidence can make to public policy and provides the society and government with tools that allow one to be more effective and critical

The Distinctive Approach

- Processes: Understanding the socio-political and economic dynamics and complexities inherent in each stage of the policy process and its impact on outcomes.
- Global Insights: Drawing lessons from the experiences of different policy regimes –
 working through the public, private and third sectors from across the world.
- **Interconnectedness:** Appreciating policy as an inter-related discursive field such that one policy sector invariably affects the other with differential impacts on the economy, social groups and regions.
- Design: Research leading to the development of relevant institutional needs to address developmental aberration(s) and policy gaps.

Action Plan

- Research and Consultancy: Knowledge creation and dissemination on a wide spectrum and dimensions of public policy issues for the various stakeholders of the public policy.
- Capacity Building: Supporting different stakeholders of the public policy in the need
 of capacity building in the domain of public policy to enable them to serve society in a

better way.

• Short-term Orientation Courses: Conduct thematic short-term courses for the different levels of the stakeholders to lend them deeper insights into the issues of

concern.

• Collaboration: Create an inclusive public policy ecosystem with other institutions of

repute in India and abroad having synergy.
