

1. About CIMP



Chandragupt Institute of Management Patna (CIMP) was established as an autonomous institution in 2008 with active support from the Government of Bihar. The institute was established to contribute substantially to Bihar's academic and development credentials while fulfilling the primary role of training students to become professional managers. CIMP offers a two-year full-time Post Graduate Diploma in Management (PGDM), approved by AICTE and accredited by the NBA. The programme is recognised by the Association of Indian Universities (AIU) as equivalent to MBA. Along with this, it offers a doctoral-level Fellow Programme in Management (FPM) approved by AICTE. Recently, CIMP started offering two new programmes from the academic year 2022: the Executive Fellow Programme in Management (EFPM) and the Post Graduate Diploma in Management —Innovation, Entrepreneurship and Venture Development (PGDM—IEV).

CIMP has also initiated an eleven-month Executive Programme in Management sponsored by the Government of Bihar. CIMP also started the AICTE-approved Fellow Programme in Management in 2018. In a span of 16 years, CIMP's achievements are known to the corporate world. The graduates from CIMP are placed in various companies of national and international repute, such as Amul, GIC HFL, LIC HFL, HDFC AMC, HDFC Ltd., Federal Bank, Asian Paints, Colgate Palmolive, ICICI Bank, Bandhan Bank, ITC, NDDB, Tata Advanced Systems, Yes Bank and many more.

NBAAccreditation

The Post Graduate Diploma in Management (PGDM) offered by CIMP is accredited by the National Board of Accreditation (NBA). Students studying in an NBA-accredited institution can be assured that they will receive an education that balances high academic quality and professional relevance and that the needs of the corporate world are well integrated into programmes, activities, and processes.

This accreditation also signifies that the professionals developed here are of international standards and would be very useful in enhancing their global mobility.



AIU Approval

The Association of Indian Universities (AIU) has accorded equivalence to the two-year full-time PGDM Program offered by CIMP with a Master of Business Administration (MBA) Degree from an Indian University.



Institute Achievements

CIMP has obtained approval from the All-India Council for Technical Education (AICTE) for conducting a full-time Post-Graduate Diploma in Management (PGDM) with 120 seats, Fellow Programme in Management (FPM) with 05 seats and Executive Fellow Programme in Management (EFPM) with 15 seats for the academic year 2022-2023. Recently, CIMP started a Post Graduate Diploma in Management – Innovation, Entrepreneurship and Venture Development (PGDM – IEV) in the academic year 2022-23. CIMP secured a National Cluster Rank of 60 in the MBA ranking in 2024 in the Indian Institutional Ranking Framework (IIRF).



NIRF Ranking

CIMP has secured a rank band of 100-125 in the National Institutional Ranking Framework (NIRF) for the year 2023. NIRF is the sole ranking system approved by the Ministry of Education, Government of India. It follows a comprehensive methodology to evaluate and rank educational institutions across the country. The ranking criteria encompass several key aspects, including teaching quality, research activities, graduation outcomes, outreach efforts, inclusivity, and overall perception of the institution.



2. Industry-Academia Interactions

2.1. MoU with Georgia State University and its Andrew Young School of Policy Studies

Georgia State University, established in 1913, fuses academic excellence with a comprehensive college life, empowering students to achieve their goals, expand the boundaries of knowledge, and develop into exceptional leaders. With one of the most diverse student populations in the country, the university offers associate to graduate-level education to a vast number of students across its main campus in downtown Atlanta and five Perimeter College campuses.

This MoU aims to foster and promote mutually beneficial scientific, technological, educational, and other collaborations, including faculty and student exchange programs, joint research initiatives, and cooperation on third-party funded educational or economic assistance activities. The exchange of postgraduate students for specific research projects or courses, as well as the sharing of scientific and educational literature and materials produced by either party; collaboration on the most pertinent and current research conducted by researchers at both Georgia State and CIMP; and the organization of conferences, seminars, and symposia of mutual interest to the institutions.



2.2. MoU with Indo-European Education Foundation (IEEF)



Indo-European Education Foundation

A bridge between India, Poland and EU

The Indo-European Education Foundation (IEEF) is an NGO and research centre situated in the heart of Central Europe, specifically in the capital city of Poland, Warsaw. IEEF offers a distinct platform for students, scholars, and business professionals based on an Academia-Industry Interlinked Model of Business Cooperation.

The MoU between CIMP, India and the IEEF aims to foster academic collaborations with European universities, industries, and research projects. The agreement encompasses joint activities such as forums, conferences, seminars, lectures, online courses, research initiatives, workshops, projects, publications, and training programs for students, scholars, and corporates. It also includes non-academic cooperation to support project development and partnerships with European institutions. Furthermore, the MoU facilitates corporate partnerships by offering internships, counselling for studying abroad, support for new courses, and training programs tailored for students and scholars. Additionally, it introduces initiatives like the Academia-Industry Experience in the EU (AIEEU) for short-term training and extended 3 to 6-month industrial training opportunities within the EU.

2.3. MoU with Smart Village Movement in Alliance with Berkeley Haas

Smart Village Movement[™] In Alliance With Berkeley Haas

Smart Village Movement (SVM) in alliance with Berkeley Haas promotes open innovation for sustainable rural development. They primarily engage with state governments, academic institutions, and corporations in India for socio-economic development in emerging rural communities. SVM provides a platform for stakeholders from various sectors to collaborate to build access to technology and market-centric models to increase overall standard of living and quality of life in rural areas.

This MoU signed on June 3, 2024, aims to establish a mutually beneficial collaboration to achieve economic and entrepreneurship development, especially in rural India. The primary objective of the MoU is to foster innovation, prepare products for market entry, and evaluate and refine the solutions and technologies of start-up enterprises in the rural market.

2.4. MoU with Behaviour Change Advisory Services LLP



Behaviour Change Advisory Services (BCAS) partners with the Indian government to implement large-scale programs for smallholder farmers. Utilizing human-centred design, behavioural science, and thorough research, BCAS identifies farmers' constraints and creates tailored services to address them. While BCAS primarily offers customized digital advisory services, it also scales innovations to benefit farmers.

This MoU, executed on June 3, 2024, seeks to foster collaboration in identifying and creating research initiatives and programs aimed at improving the livelihoods of smallholder farmers. These initiatives will be rooted in scientific research, with the goal of enhancing decision-making and service delivery for smallholder farmers. With the backing of CIMP and the CIMP Foundation, BCAS will work to scale existing innovations and develop new ones that will benefit smallholder farmers in a sustainable manner.

2.5. MoU with Aryabhatta Knowledge University



Aryabhatta Knowledge University (AKU), recognized as a State University affiliated with the University Grant Commission (UGC), was established to oversee and enhance educational facilities related to professional education and new frontiers of learning and knowledge. The University's primary goal is to elevate the standard of professional education by offering advanced programs, state-of-the-art infrastructure, and a high-competence faculty. Additionally, AKU functions as an affiliating university, conducting over a hundred courses under various Schools of Faculties and granting affiliation to deserving technical and professional private colleges.

On January 3, 2024, CIMP signed a MoU with Aryabhatta Knowledge University. This MoU aims to foster a culture of academics, research, consulting, training, knowledge sharing, and faculty development and exchange between the two institutions. It also envisions the creation of joint programs to further strengthen their collaborative efforts.

2.6. MoU with Babasaheb Bhimrao Ambedkar Bihar University



Babasaheb Bhimrao Ambedkar Bihar University, more commonly known as B. R. Ambedkar Bihar University (BRABU), is a state institution located in the city of Muzaffarpur in the northern part of Bihar state, India. Established in 1960, this university boasts 37 constituent colleges and offers distance education courses. In addition, the university hosts symposiums, seminars, and workshops. It is a top-tier teaching and learning institution in the city, offering full-time and part-time courses ranging from undergraduate to postgraduate and research levels.

The primary objective of this MoU is to create a collaborative agreement between Brahmananda Narayan University (BRABU) and the Centre for Industrial Mathematics and Physics (CIMP). This partnership aims to foster a culture of academics, research, consulting, training, knowledge sharing, faculty development, and exchange, as well as joint programs between the two institutions.

2.7. MoU with Vivekanand Education Society Institute of Management Studies and Research (VESIM)



VESIM has been a frontrunner in business education, fostering leaders who aim to make a positive impact on their workplaces, communities, and society. VESIM offers the Master of Management Studies (MMS) program. MMS is a two-year, full-time management program, spread over four semesters (two per year), and approved by AICTE, Govt. of India, and recognized by the University of Mumbai.

The MoU between the CIMP and VESIM aims to leverage their respective strengths by exploring a mutually beneficial relationship. This relationship may include, but is not limited to, the following activities: joint teaching, training, executive education, Continuing Education Programs (CEPs), and Technology-enabled Education Programs (TEPs); Dual Degree programs; collaboration on management consulting and research projects, sponsored or otherwise; organization of joint events such as symposia, conferences, seminars, colloquia, and workshops; and promotion of institutional exchange between teaching and non-teaching staff.

2.8. MoU with StrateRise Consulting Pvt. Ltd



StrateRise Consulting Pvt. Ltd, which is a new age Strategic communication, Reputation management, Crisis Communication and ESG company that focuses on brand growth and shareholder value enhancement.

The MoU between CIMP Business Incubation & Innovation Foundation (CIMP BIIF) and StrateRise Consulting Pvt. Ltd has signed on April 29, 2024. The primary objective of this collaboration is to provide integrated strategic communication, branding, reputation management, and ESG support to entrepreneurs in Bihar.

2.9. MoU with Bihar Animal Sciences University



Bihar Animal Sciences University (BASU), situated in Patna, commenced operations on June 13, 2017, with the appointment of its inaugural Vice Chancellor. Established by the absorption of two constituent colleges in Patna—Bihar Veterinary College and Sanjay Gandhi Institute of Dairy Technology—and the establishment of College of Fisheries in 2018, BASU emerged from Bihar Agricultural University.

This MoU between CIMP and BASU, executed on May 06, 2024, aims to forge a collaborative framework between Bihar Animal Sciences University (BASU) and GIMP. The MoU focuses on fostering a culture of academia, research, consulting, training, knowledge sharing, faculty development and exchange, and joint programs between the two institutions.

2.10. MoU with Jay Prakash University



Jay Prakash University (JPU), Chapra is a State University that is affiliated with the University Grant Commission (UGC). The university was established to improve and expand educational opportunities in Professional Education and emerging fields of knowledge. JPU's main objective is to raise the standard of professional education by providing advanced programs, cutting-edge facilities and a highly qualified faculty.

On May 15, 2024, JPU and CIMP signed a Memorandum of Understanding (MoU) to encourage a culture of academics, research, consulting, training, knowledge sharing, and faculty development and exchange between the two institutions. The MoU also aims to establish joint programs that will further strengthen their collaborative efforts.

3. Conference and Workshop

3.1. Second International Financial Management Conference (IFMC) 2024

CIMP hosted the Second International Financial Management Conference on February 09, 2024, in Hybrid Mode. This seminar served as a platform for research scholars, academics, and industry professionals from diverse backgrounds to come together and engage in discussions regarding the latest trends and best practices in the domain of Green Finance, Financial markets, Sustainable Finance and Financial Inclusion. The event started by lightening the ceremonial lamp by Prof. Dr Rana Singh, Director of CIMP (Patron, IFMC), Dr Anubha Prasad (General Manager, SIDBI) as chief guest, Mr. Kumod Kumar, CAO CIMP, Prof. Santosh Kumar, Chairperson (IFMC,2024) and Prof. Ranjit Tiwari, Convenor (IFMC,2024). It was followed by a welcome speech by Director CIMP.



The session was further addressed by Dr Anubha Prasad who is General Manager with SIDBI and founder of Karekeba Ventures. During the speech, she highlighted the impact of a strategic roadmap in finance, the importance of green finance, and Sustainable Development Goals 2030 with a note "Greening the Finance and Financing the Green". The Keynote Speaker (Industry), Mr Kumar Anand, MD & Head, S Cube Capital, Singapore, who joined in virtual mode, delivered his keynote address on "The Need for Green Infrastructure, Focus on Local Product and Public Private Partnership". The Guest of Honour (Industry), Mr Kumar Ayashkanta, Group Chief Investment Officer, Wipro Enterprises, who joined with a virtual presence, discussed the

investment psychology, problems faced by the investors and the importance of fundamentals while investing.

The conference featured a wide range of topics like Green Finance, Financial markets, Sustainable Finance, Financial Inclusion, Financial Performance, and Digital Learning, among others. Out of the total 43 paper submissions received, 29 were accepted and registered, among which 28 were presented at the conference.

The conference was conducted in 5 parallel technical sessions with research paper presentations from various institutes. The seminar was meticulously structured to serve as a forum where academicians, researchers and students could exchange their knowledge and perspectives. This gathering presented attendees with an exceptional chance to gain insights from some of the foremost authorities in these fields,

encompassing Green Finance, Green Bonds, Financial Literacy, Financial Inclusion and Transparency. A total number of 3 overseas institutions took part in the conference, including Chung Yuan Christian University, Taiwan, Oklahoma State University, United States and Pennsylvania State University, United States. At the same time, the number of National institutions that took part in the conference was 22, including institutes of eminence like IIM Ranchi, BIT Mesra, IIM Sambalpur, BHU Varanasi and others.



During the valedictory session, the Keynote Speaker (Academia), Dr Sudarshan Paramati, Professor, School of Business at the University of Dundee, UK, delivered his keynote address on "Climate change CO2 emissions and reduced emissions for attaining sustainability goals". Further, the Guest of Honour (Academia), Dr Gopal Krishna Sarangi, Associate Professor, TERI School of Advanced Studies, shaded light on "Repositioning of States and Changing Geopolitics and Complementarity and Sustainability". Finally, Prof. Sibananda Senapati summarized the conference and boosted the spirits of the attendees with his words of wisdom. The best paper award was given to Jo Hui Chen and his co-authors for their paper "The Spillover Effects of Volatility: The Study of Innovation for Carbon Emission ETFs", with a prize of INR 10,000. The session was concluded with a vote of thanks by Prof. Santosh Kumar, along with certificate distribution to the participants and announcement of the Third International Financial Management Conference to be held in February 2025.

3.2. Stakeholder Consultation Workshop (PM-KISAN)

A stakeholder consultation workshop was held on March 13, 2024, to discuss the findings of a study titled "Impact Evaluation of the PM-KISAN Scheme: A Study of Selected Areas of Bihar and Assam", awarded by the Indian Council of Social Science Research, Ministry of Education, Government of India, organised by Chandragupt Institute of Management Patna (CIMP). The event brought together key stakeholders of the PM-KISAN scheme, including beneficiaries from different districts of Bihar, representatives from the bank, academicians, policy experts, research scholars and others.





Prof. (Dr) Rana Singh, Director of the Chandragupt Institute of Management Patna (CIMP), welcomed the dignitaries and stakeholders. He congratulated the project team for completing the study and expressed gratitude to the Indian Council of Social Science Research (ICSSR) for their generous funding. Dr Debabrata Samanta, Project Coordinator, highlighted the findings of the study and how the scheme has positively impacted the lives of beneficiary farmers in Bihar and Assam. The study offers a range of policy recommendations, including emphasising information channels for disseminating proper information and special initiatives for landless farmers and women beneficiaries.

Selected beneficiaries from Bihar shared their views about the scheme, including their consumption patterns and challenges. Mr Sanjay Kumar Srivastava, General Manager, and Mr Kunj Bihari, Assistant General Manager from Dakshin Bihar Grameen Bank, discussed the bank's role in implementing the PM-KISAN scheme. They elaborated on credit-linked poverty alleviation programs, challenges faced by beneficiaries, and various bank schemes to improve financial inclusion. They expressed their gratitude towards the PM KISAN database for providing them with a comprehensive list of potential borrowers or target groups.

A subsequent roundtable discussion featured valuable insights from policy experts, including Prof. Deepak Kumar Behra (National Institute of Technology Patna), Prof. Sriranga Vishnu, and Prof. Ankit Sharma (both from CIMP). They provided critical policy analysis and potential pathways for improving farmer welfare.

Field investigators from Assam and Bihar shared their experiences collecting data and presented qualitative findings from the research. In the end, Dr Sibananda Senapati summarised the project, and

Dr Debabrata Samanta offered a vote of thanks to all the stakeholders. This collaborative workshop provided a crucial platform for exploring the PM-KISAN scheme's impact and identifying future directions to ensure its optimal benefits for farmers.

3.3. International Conference on Public Policy and Management

The 2024 International Conference on Public Policy and Management (ICPPM), organized by the CIMP in collaboration with Georgia State University on June 17 and 18, 2024, focused on the theme "Promoting Good Governance and Local Development in Bihar and Beyond: The Latest Scholarship and Practice." The conference brought together a diverse group of experts, practitioners, and scholars to share insights and innovative solutions aimed at advancing sustainable development and governance in Bihar.



The event kicked off with a session on "Governance and Community Engagement", where Brijesh Mehrotra, IAS, Chief Secretary, Government of Bihar, emphasized the critical role of capacity building, academic collaboration, and community-based progress in driving development in Bihar. His insights set the stage for a series of enriching discussions and presentations that followed.

A panel discussion titled "Governance on Ground: Insights from Bihar" featured several key speakers. Sandhya Kumari and Shusumlata provided insights on female leadership and digital panchayats, and Shilpee Kumari addressed the need for male participation in breaking traditional patriarchy.

Additionally, Mr Chandan Jha, Prof. Sibananda Senapati, Nitish Nigam, Dr Indrajeet Kumar, Dr Parmeet Kumar Vineet, Dr Utsav Kumar, and Dr Debabrata Samanta discussed subjects like climate-smart agriculture, the social impact of land acquisition, the electric vehicle market in Bihar, and agricultural policies.



Entrepreneurship in Bihar was the focus of another session, where Divyanshu Verma, Dilkhush Kumar, Richa Vatsyayan, Aastha Singh, and Akash Kumar shared their entrepreneurial journeys, technological advancements, and policy challenges. Their discussions highlighted the vibrant entrepreneurial spirit in Bihar and the potential for innovation-driven growth. The conference concluded with reflections from Prof. (Dr.) Rana Singh, an MDI Alumni and Accreditation Specialist, and Kumod Kumar. 



10. Beyond The Classroom: Conversation With Our Faculty

10.1. Transforming Farmers' Lives through PM-KISAN: Dr Debabrata Samanta Shares Insights from an ICSSR-Sponsored Project

Interviewed by Kumari Nisha Roy and Ujjwal Kumar

Dr Debabrata Samanta, in a conversation with Kumari Nisha Roy and Ujjwal Kumar, shedded light on his recently completed ICSSR-funded project evaluating the impact of the PM-KISAN scheme on farmers in Bihar and Assam.

Kumari Nisha Roy and Ujjwal Kumar: Sir, it is our pleasure to talk with you regarding your recently completed project sponsored by ICSSR. We congratulate you on the successful completion of this project. Thank you for taking the time to share insights from it with us.

Dr Debabrata Samanta: Thank you. I am happy to discuss our findings.



Dr Debabrata Samanta, Ph.D., from the Indian Institute of Technology, Kharagpur, is an Assistant Professor of Economics at CIMP. He has provided research and consultancy support to various departments of the Government of Bihar, the Ministry of Rural Development, Government of India, and the World Bank, Washington, D.C. Dr Samanta has contributed to significant World Bank reports such as the 'Land Governance Assessment Framework, 2015' and 'Enabling the Business of Agriculture, 2017'. His research primarily focuses on governance and public policy issues.

1. Could you provide an overview of the key objectives and methodology of the study?

The primary objective of our study was to evaluate the impact of the PM-KISAN scheme on farmers in Bihar and Assam, focusing on how financial aid was utilized and its effect on agricultural productivity and household needs. We aimed to explore the process of beneficiary registration and fund distribution, gender disparities, and differences in spending patterns between the two states. Our methodology was a mixed-method approach, combining qualitative and quasi-experimental methods. We collected data from over 2,000 farmers across six districts, three in each state. This approach allowed us to capture both the quantitative impact and qualitative experiences of the beneficiaries.

2. What were the major findings of the study regarding the impact of the PM-KISAN scheme on the income levels of farmers in Bihar and Assam?

One significant finding was the discrepancy between registered and eligible beneficiaries. In Assam, farmers primarily invested the funds in agricultural activities, which positively impacted their productivity and, consequently, their income. In contrast, Bihar farmers used the funds for both agricultural and non-agricultural purposes. Additionally, large landowners in both states found the amount less impactful on their overall income due to the relatively small size of the aid compared to their total earnings.

3. Could you elaborate on the positive impacts of the scheme on the lives of beneficiary farmers that were observed during the study?

In Assam, the scheme's funds were often used to start new businesses and invest in education and health, leading to broader socio-economic benefits beyond just agriculture. This indicates that the scheme helped improve overall quality of life and economic stability for these beneficiaries. In both states, we observed that even small financial aid helped farmers manage their cash flows better, providing a buffer against unforeseen expenses and helping them plan for future agricultural activities.

4. How did you ensure effective time management and prioritization of tasks throughout the different phases of the study?

Effective time management was crucial for the success of this large-scale study. We divided the project into distinct phases: planning, data collection, analysis, and reporting. Each phase had clear milestones and deadlines. We held regular team meetings to monitor progress and address any issues promptly. Prioritization was guided by the project timeline and the criticality of each task. For instance, data collection was prioritized during the farming seasons to capture accurate and relevant data.

5. What specific initiatives or measures were suggested in the study to better support landless farmers and women beneficiaries under the PM-KISAN scheme?

To better support landless farmers and women beneficiaries, the study suggested several measures. For landless farmers, we recommended extending the scope of the PM-KISAN scheme to include tenant farmers and sharecroppers. For women beneficiaries, we emphasized the need for targeted awareness campaigns to ensure higher registration and participation. Additionally, providing financial literacy and training programs for women could enhance the effective utilization of the funds, ensuring they reap maximum benefits.

6. As a project coordinator, what were the major challenges you faced in managing and coordinating a large-scale study like this?

One of the major challenges was recruiting suitable research staff, particularly for fieldwork in Bihar, due to limited salary resources. Another challenge was navigating the contrasting spending patterns observed between Bihar and Assam farmers, which required a nuanced approach to data analysis. Additionally, ensuring timely data collection and maintaining the quality and consistency of data across different locations posed significant logistical challenges. Effective communication and regular coordination with field teams were essential to overcoming these challenges.

7. From a student's perspective, what valuable lessons or skills did you acquire through this research project that could be applicable in academic or professional settings?

Through this research project, I acquired several valuable skills, including project management, data analysis, and fieldwork coordination. I learned the importance of flexibility and adaptability in managing research projects. Additionally, I gained insights into effective team management and the significance of clear communication. These skills are highly transferable to both academic and professional settings, where project timelines and team dynamics are crucial to success.

8. Based on your experience with this project, what advice would you give to students or researchers interested in pursuing similar impact evaluation studies or policy-oriented research?

My advice to students or researchers would be to develop a thorough understanding of the context and objectives of their research. It's essential to employ a mixed-method approach to capture both quantitative and qualitative data. Building a strong and committed research team is crucial, as is maintaining flexibility to adapt to unforeseen challenges. Lastly, effective time management and clear communication are key to ensuring the successful completion of any large-scale research project.

9. Could you share any interesting or noteworthy experiences or observations from the study that would help students in the research field?

One noteworthy experience was observing the diverse ways in which farmers utilized the PM-KISAN funds. In Assam, some beneficiaries used the money to start small businesses, which was an unexpected but positive outcome. This highlighted the scheme's potential to stimulate rural entrepreneurship and economic diversification. Additionally, we found that personal networks in Bihar played a significant role in information dissemination, underscoring the importance of understanding local contexts and social dynamics in research. These observations reinforced the need for researchers to remain open-minded and attentive to the nuances of their study environments.

Death could come to you if always dwell in the past.


You could appreciate it, or you could resent,

after the 1st January of 1981, but here was a 13 years older prospective student like me, whose date of birth had been the 1st January of 1968.

I had then visited the CIMP and had met our Director Sir, who had only recently joined as Director. When I explained my issue to me, his response was full of dynamism and empathy. He told me that I must have missed to check my mail-box. In fact, he had already got the issue resolved, after having received my mail sometime back. It was me, who had not expected such a prompt response. I had then thanked him. The same day, in the night, when I had been free from my office and family duties, I had been able to log into the CIMP Admissions Portal, without any block on account of my Date of Birth.

However, after I started filling in the online Admission Form, there was another block. The system made it mandatory for the Applicant to mention his/her father's telephone/Mobile number. But my father had

expired long back in 2001, and he had no telephone/mobile number in his lifetime. I had then immediately written an email to our Hon'ble Director Sir, who had again been pleased to have got the issue resolved the very next day. So, I had been able to successfully apply for my admission to the PGDM Programme at CIMP, in the 2022-24 batch.

But it was still not so easy even thereafter. After I had got the Offer of Admission from the CIMP, I had applied for the Grant of Study Leave of 2 years, to the Hon'ble Director General, ICAR, Union Ministry of Agriculture, Krishi Bhawan, New Delhi. After my repeated reminders, when the approval did come, it was November, 2022. It was then that I had rushed to the CIMP, where I had first encountered "No" as the answer, when I really felt that I had missed the Bus. But then, it was solely because of our Hon'ble Director Sir's kindness and proactive leadership qualities that I was ultimately able to get admitted to the PGDM Course at CIMP, in the 2022-24 batch.

Had I not been admitted in the 2022-24 batch, I would not have been able to subsequently apply for admission. The Study Leave Rules of the Central Government stipulate that the Study Leave of an Officer must end at least 3 years prior to his/her Date of Retirement. Accordingly, I was eligible to avail Study Leave only upto the 31st December, 2024, not beyond. As such, it would have not been possible for my employers to have entertained my request for Study Leave to any subsequent batch beyond the 2022-24 batch.

Now, I would hopefully be able to complete the most of my PGDM course by the end of December, 2024. Since I had missed my first 2 Trimesters of the 2022-24 batch, I would now need to complete these remaining Trimester-courses during the second half of the ongoing year, 2024. As per the CIMP guidelines, a PGDM student is allowed to complete his/her PGDM courses, within the maximum permissible period of 4 years, from the date of his/her admission.

Ultimately, I now do feel that my dreams are on track. I am now studying at CIMP. It has indeed been a great privilege for me to have been studying here. The CIMP is truly the Mecca of Management education in our glorious State of Bihar. The Professors here are the gem. Many of them have an envious international background, and many have been the alumni of our national apex management and technology institutions like the IIMs, IITs, NIFM, IRMA, NIETI (now, IIM Mumbai), etc.
