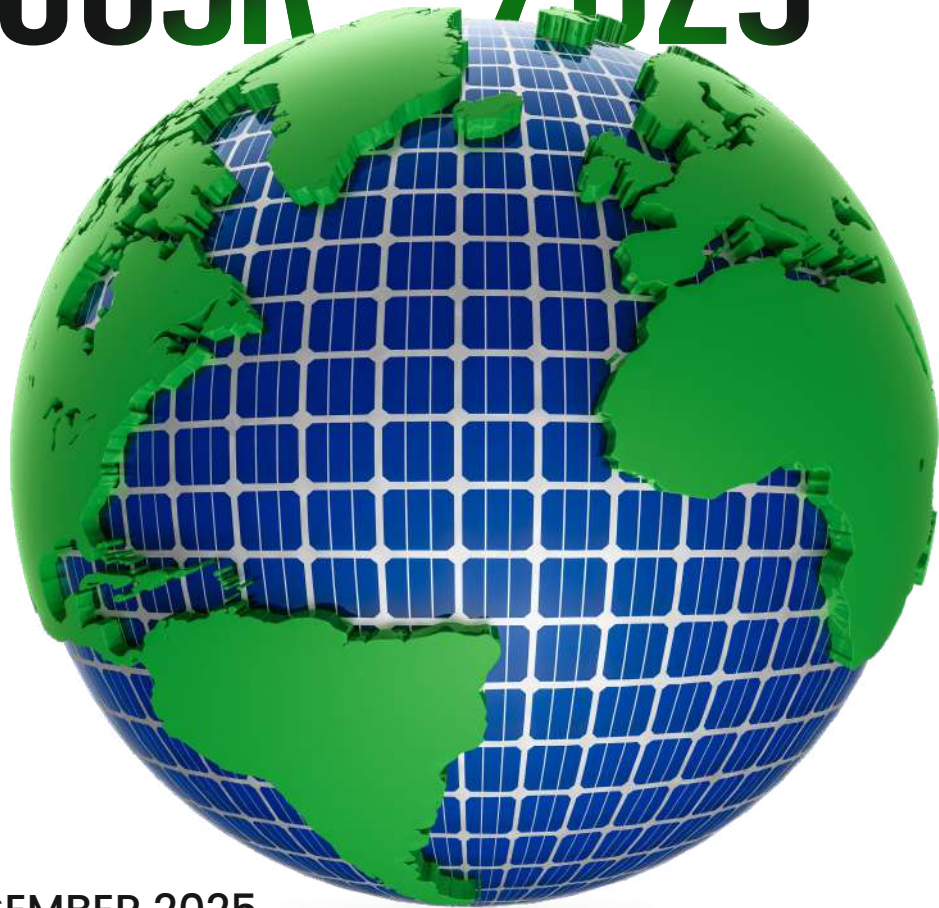

## **ABOUT THE CONFERENCE**

## AWARDS AND RECOGNITIONS

### Best Paper Award

The best paper selected by a panel of experts at the conference will be eligible for the Best Paper Award of **INR 20,000** and a Best Paper Certificate in the Academic/paper presentation category.



All paper presenters (below 35 years of age with a valid identity card of his/her affiliation and proof of date of birth) need to register for the conference by paying the appropriate fees.

### CIMP AWARD for Best CSR Practices

This award/citation will be provided in two categories: the First one, CSR practices at the India level (Gold category), and the second one, CSR practices at the Bihar level/region (Silver category).

#### The following are the guidelines for submission for the award

- All the submissions need to be presented orally at the conference (online/offline) in a particular pre-decided session.
- A panel of expert members will evaluate the abstract/full paper/ case submission, as well as the presentation.

- The submission for this award could also be in the form of a small video (10 to 12 minutes).
- If you are submitting a case study, the photographs of the interventions need to be included in the documents.
- All the guidelines mentioned under abstract submission and full paper submission need to be followed.
- Any incomplete submission will be rejected.
- All paper presenters need to register for the conference by paying the appropriate fees.

## **SUBMISSION GUIDELINES**

### **Abstract Submission**

- We invite Abstracts with a limit of 250–300 words from academicians, researchers, practitioners who want to present a research paper, literature review, case research and case study in the conference
- The Abstract must include a suitable title, objectives, details about sampling or the field study/community where the experiment has been conducted, the Method of analysis, and the results interpretation
- Identify a suitable theme and submit the abstract relating to a particular theme as highlighted above

### **Full Paper Submission**

Full papers submitted to previous conferences are published in conference proceedings, published by Bloomsbury Publishing New Delhi.

This year, the full paper/case study submitted will be evaluated and will be considered for publication as an edited book/journal article. The guidelines for full paper submission are as follows.

- Full paper should be of 3000–5000 words.
- Abstracts and full papers are to be sent as a MS-Word Document.
- Font style should be 'Times New Roman'.
- Font size '12' and endnote font size '10' to be maintained.
- Text alignment should be 'Justified'.

- Line spacing should be '1.5'.
- References included in full papers submitted must follow APA citation style.
- The organising committee reserves the right to disqualify any paper not related to the theme of the conference or not adhering to the submission guidelines.
- Abstract and Full paper may be emailed to [iccsr@cimp.ac.in](mailto:iccsr@cimp.ac.in)/ or using the QR code given.
- Plagiarized submissions will be subject to disqualification (similarity index should not be more than 10%).

## **OTHER GUIDELINES FOR THE PARTICIPANTS**

Registration is mandatory upon confirmation of the abstract. Only registered participants will receive the certificate and will be allowed to take part in the conference. Presenters can participate in the conference in online or offline mode. Paper presenters (authors and co-authors) have to register individually after the acceptance of the abstract with payment of the registration fees as applicable. There will be no change in the paper as well as the name(s) of authors/ co-authors once a paper is accepted. Submission of the full paper is mandatory for consideration for the best paper award. We do not have any provisions for the payment of transport allowance or reimbursement of travel expenses.

## **ACCOMMODATION**

Outstation paper presenters will be provided with accommodation on the campus. Other accompanying guests and participants can book their accommodation on campus by paying INR 750 per night (including food).
